OUTSTANDING PROJECTS TO BE COMPLETED

Second round of camera install – Dandridge pool and one entrance has a new camera system connected to Project NOLA. This is a test round to sort out power and connectivity, and more will be installed soon. The board reviewed strategy for new camera installations.
